2.	Declarations of Interest and Applications for Dispensations RJ - Item 11	
3.	Co-option for vacancy for Councillor BPC considered the idea for weekend PC meetings, however it was commented that it may be difficult for attendance from SCC, District representatives. Thank you for interest shown, however BPC continue to look for candidates for week day evening meetings. 4.	Public Session Giles Bloomfield, Project Manager for ES Internal Drainage Board, was invited to give a brief update on AOCP. ESIDB are a Risk Management Authority (similar authorities as Environment Agency) The new Alde & Ore Community Partnership is more representative of the communities, having representation from parish's, statutory members, including CCIIrs and District CIIrs. The estuary is so large - to do a single business case is incredibly onerous and complicated with lots of challenges - had to prove there's an economic case. There are causal and link effects - i.e. whilst protecting upper estuary at Aldeburgh can increase risk at Iken - unacceptable to increase anybody's flood risk temporarily - looking at zones which can be done simultaneously - i.e. wall raising at lower estuary Sudbourne would impact on Butley and Chillesford. Lower estuary in Boyton area has been flagged up by Natural England and continuously monitored. Looking at climate change best and worst case sea levels predictions and health of fresh water habitats. The plan for improvement scheme is to design the walls which makes	Clerk

them more adaptable and resilient to climate change/storm surge events. Widen top of wall and change gradient at backface. Overview given of total costs and funding - Business case for upper estuary ready within a couple of months. Lower estuary more traditional ways of pricing. Boyton flood defence system area going back to NE - if sea level rise does occur an agreement with landowners and RSPB option to flood up the land - not determined. JP query can Boyton input on any decision making - AOCP are primarily route in - improvement in communications going forward. GB happy to help with queries.

AC in absence of AR to note looks increasingly positive for funding for around 100 kilometres of roads designated as quiet lanes, therefore expanding right of way for pedestrians, cyclists and horse riders. Draft case put forward looks viable subject to a formal application for 2020/21, with additional money from ES District Council - about 70 lanes designated over next 12-13 months. JM conveyed thanks to AC for all his hard work

BPC has received an email and photographs from a resident regarding extreme mud on the road in Mill Lane again - report to Highways (add to AR road issues meeting on 17)

Concern was raised about light pollution from prison - seems to have increased

Defibrillator to be tied in to Emergency Plan, x2 bridges in Boyton wood installed by Highways completed, Coastal Path - JP emailed to information team and comments received and answered. Repairs to Church hall - JP followed up with SALC on options - they clarified change of ownership would change the situation such that there may be no restrictions on funding. Minutes agreed

7 Update of meetings attended by Cllrs

- (i) East Suffolk Budget/Strategic plan RJ attended
 - The new budget will be part of the ES MTFS (Medium Term Financial Strategy) four year forecast to 2023/24.
 - Two new priorities in the strategic plan this year (digital infrastructure and environmental sustainability): this implies more video meetings for the council, more available online and initiatives to counter climate emergency.
 - Central government funding is now a very small part of district council budgets: whereas it was around 20% five years ago, any central government funds now need to be applied for on a case by case basis (eg Coastal Towns Fund).
 - Currently council tax represents just under 60% and business rates 40% of the annual ES budget - with economic uncertainty affecting bricks and mortar retail for example the council needs to look at potential for taxing online businesses.
 - Good news for us: the council tax referendum principle only applies to district and county councils (any increase over 2% must be approved by a referendum of residents) however this doesn't apply to town or parish councils

	(ii) A&O Community Partnership (AC) and Communications Meeting (RJ) As GB presentation and Minutes circulated. Minutes of Comms meeting - to be circulated once received - working on defining various public messages and communications - possible job for PR Agency	
	(iii) East Suffolk Community Partnership - JP attended - Village hubs and young people areas discussed - transport was dissuaded as this would be discussed at the Board Meeting - slightly concerning that we didn't have any transparent input to the Board Meeting (on which we are represented by an ES Council rep). i.e. the best idea from our group was transport around villages to special events at village hubs (or regular youth events) on the peninsula but we were not allowed to prioritise this as it was seen as a transport issue. Of the ideas we were allowed to vote for, those prioritised were (i) communication of existing youth engagement activities/opportunities, and (ii) support to existing village hubs. The next meeting is planned for 30 March in Rendlesham JP happy to attend.
